



Privacy Policy

Math-Knots, LLC ("www.Math-Knots.com", www.a4ace.com, "we" or "us") recognizes the importance of your personal privacy. We know that you care how information about you is used and shared, and we appreciate your trust that we will do so carefully and sensibly.

This Privacy Policy is created to let you how we use and disclose your information to us. The Privacy Policy below discloses our best practices regarding information collection and usage from our website www.math-knots.com & www.a4ace.com (the "Service") (desktop, mobile version, or any other form).

Your use of the Service is conditioned on your acceptance of this policy.

Key aspects of our privacy practices described in this Privacy Policy include the following:

Personally, Identifiable Information That We Collect:

1. Parent and Child Information:

- a. When a parent or guardian ("Parent") registers for an account on our Service or corresponds with us, we may collect personal information such as a name, grade, school name, state, Zip code, country, e-mail address, phone number, payment information, username and password. We may also collect information about the child(ren) authorized by the Parent to use the Service through the Parent's account or individually signed up by parent. **Each membership account will have a profile name for the child user, and he/she can choose an avatar. Each child user profile may be associated with a Parent account or an independent account created by parent.**
- b. We generally do not collect personally identifiable information such as date of birth from children under the age of 18. If at any time in the future we plan to collect personally identifiable information from children under 18, such collection and use, to the extent applicable, shall, when required, be done in compliance with the Children's Online Privacy Protection Act ("COPPA") and appropriate consent from the child's parent or guardian will be sought where required by COPPA. When we become aware that personally identifiable information from a child under 18 has been collected without such child's parent or guardian's consent, we will use all reasonable efforts to delete such information from our database.





2. Practice and usage Information:

During the course of providing the Service, we collect information about your use of the Service, as well as any information that you submit to the Service, such as answers to questions, no of tests taken and number of times etc. In addition, we may ask you for personal information at other times, such as when you contact our technical support team, send us an e-mail, complete a user survey or other communication to Math-Knots LLC

3. Data analysis:

- a. We and our vendors or partners may automatically collect non-personally identifiable information from you, during the use of our Service/s or use www.math-knots.com and /or www.a4ace.com services, such as IP host address, web pages viewed, browser type, operating system, referring service, search information, device type, page views, usage and browsing habits on the Service and similar data. This information is typically collected through a variety of tracking technologies, including cookies, web beacons, Locally Stored Objects, log files, and all other similar technology (collectively, "all tracking technologies"), and we may use third party providers to collect this information on our behalf. These tracking technologies collect information about how you access and use the Service (e.g., referring / exit pages and URLs, how frequently you access the Service, the pages you view, the links you click, and other actions you take on the Service); information about your browser and information about the device(s) you use to access the Service such as IP address, browser type, browser language, Internet service provider, device type, model and manufacturer, a unique ID that allows us to uniquely identify your browser, device or account, operating system brand and model, and whether you access the Service from multiple devices.
- b. We may use the collected information for aggregate demographic information about your geographical location data at the state or county or city level (aggregated data doesn't include individual information). We may also collect analytics data, or use third-party analytics tools, to help us measure traffic and usage trends for the Service and to understand more about the demographics and behaviors of our users. We may also work with third party partners to





employ technologies, including the application of statistical modeling tools, which permit us to recognize and contact you across multiple devices.

- c. We use cookies to personalize content and ads, to provide social media features and to analyze our traffic.
- d. We use or may use the data collected through tracking technologies to secure the Service, improve the Service, to save you time, to provide better technical support, for promotional purposes, and to track website usage. For example, tracking technologies help us to:
 - e. Keep track of whether you are signed in or have previously signed in so that we can display all the features that are available to you, Remember your settings on the pages you visit, so that we can display your preferred content the next time you visit.
 - f. Customize the function and appearance of the pages you visit based on information relating to your account; for example, to default you to a particular grade level or a page.
 - g. Track website usage for various purposes including website optimization, website improvement, sales, marketing, and billing.
 - h. Most browsers are initially set up to accept cookies, but you can reset your browser to refuse all cookies or to indicate when a cookie is being sent. Deleting cookies does not prevent the collection of information through non-cookie technologies and does delete Local Storage Objects (LSOs) such as Flash objects and HTML5.
- i. We may also aggregate information collected offline in connection with the Service or use of our services, obtain non-personally identifiable information from third party sources and develop aggregate information by anonymizing previously collected personally identifiable information.
- j. It is possible at times when collecting non-personally identifiable information through automatic means that we may unintentionally collect personally identifiable information along with non-personally identifiable information. While we will make every effort to prevent such incidental data collection, the possibility still exists. 4. Information Usage:

- a. We will only use your personally identifiable information as described below, unless you have specifically consented to another type of use, either at the time the personally identifiable information is collected from you or through some other form of consent from you or notification to you:
- b. Personally, identifiable information collected is used in connection with providing the Service most of the times.
- c. Personally, identifiable information is used to respond to your inquires or requests.
- d. Personally, identifiable information may be used to send you emails from time to time about our services, such as new features, tests etc...
- e. We will not provide your personally identifiable information to third parties for them to contact you directly unless otherwise permitted by this Privacy Policy or with your consent.
- f. We may permit our vendors and subcontractors to access your personally identifiable information, but they are only permitted to do so in connection with performing services to Math-Knots LLC and www.math-knots.com and www.a4ace.com. We will not authorize our vendors to use the information for their own benefit unless authorized by you.
- g. We may share your personally identifiable information with third parties to further the purpose for which you provided such information to us. Please read pay pal privacy and terms of use before entering the personal debit / credit card information for payment
- h. When a need arises, we may disclose personally identifiable information as required by law or legal process.
- i. When a need arises, we may disclose personally identifiable information to investigate suspected fraud, harassment or other violations of any law, rule or regulation, or the terms or policies for our services or our sponsors.
- j. When a need arises, we may transfer your personally identifiable information in connection with the sale or merger or change of control of Math-Knots.com or the division responsible for the services with which your personally identifiable information is associated.
- k. When a need arises, we may share your personally identifiable information with an affiliate of www.math-knots.com and www.a4ace.com who is in the same corporate family who has similar privacy practices are substantially similar to ours.
- l. We may share information in aggregated and/or anonymous form that cannot reasonably be used to identify an individual. For example, Math-Knots may disclose aggregated user statistics (i.e., the total number or percentage of Math-Knots users from a particular geographic region) to





describe our services to current and prospective partners, and other third parties, promotional usage and for other lawful purposes.

- m. Non- personally identifiable or aggregate information may be used by us for any purposes as permitted by law and may be shared as needed without individually identifying a single person.
- n. We also share information about your use of our site with our social media, advertising and analytics partners who may combine it with other information that you've provided to them or that they've collected from your use of their services. You consent to our cookies if you continue to use our website.

5. Information Security:

- a. The security of your personal information is very important to us. We have implemented a variety of physical, administrative and technological safeguards designed to preserve the integrity and security of the personal information we collect and to protect against unauthorized access to data. These include internal reviews of our data collection, storage, and processing practices and security measures, as well as physical security measures to guard against unauthorized access to systems where we store personal data. We restrict access to personal information to MATH-KNOTS LLC employees, contractors, and agents who need to know that information in order to operate, develop, or improve our services. Our employees may be subject to disciplinary action, including termination, if they fail to meet privacy and confidentiality obligations. However, no security system is impenetrable—for that reason, we cannot guarantee the security of your personal information. If personal information under our control is compromised as a result of a breach of security, we will take reasonable steps to investigate the situation and take all steps required by applicable laws and regulations.
